2009-10

The Year In Review

The 2009-10 chapter year will forever be remembered by members of the AMBUCS organization as a period in which we gained positive membership growth, improved our national visibility and communication tools, and most importantly, were able to introduce to our mission to a number of new communities.



When AMBUCS President Cliff Bauerle was first sworn into office in July of 2009, he immediately announced an ambitious goal of building new AMBUCS chapters. Throughout the chapter year, our volunteer members would heed his call to action and as a result of their efforts 13 new chapters were formed.

Also in 2009-10, AMBUCS began to embrace the exploding social networking phenomenon. The organization created a new presence on Facebook, Twitter and Youtube and suddenly our members were able to communicate with one another more often and share more information more effectively.

On the AmTryke therapeutic tricycle front, the 2009-10 chapter year saw the arrival of several new exciting trike models and accessories, including the a fleet of new adult model trikes and various new seating and steering innovations.

However, perhaps the most exciting and rewarding development of the year came in April 2010, when was the entire AMBUCS organization united to compete for a \$50,000 to purchase AmTryke therapeutic tricycles for 100 individuals with disabilities on its national wish list.

Spearheaded by leaders of the national Big Hat Club, this grassroots effort took the form of a month-long online voting campaign. As part of a new community service initiative, Pepsi announced that it would award \$20 million in grants throughout the year to support ideas that “refresh the world and lead to positive change.” Each month, the soft drink maker distributed a total of \$1.3 million in grants, spread out between four different amount categories. AMBUCS chose to compete in the \$50,000 category and thus had to finish in the top ten out of more than 360 other similar entries to win the grant.

All approved ideas were ranked by the public, as people could visit Refresheverything.com and vote for projects that they wanted to see become a reality. To attract voters, AMBUCS launched a first-of-its kind marketing campaign which capitalized on nearly all of the organization’s communication tools. A special webpage was created on ambucs.org to explain how to voting process worked. A Pepsi can button was placed prominently on the website homepage which linked voters directly to AMBUCS grant campaign page. The AMBUCS Resource Center staff also sent out regular broadcast emails, direct mailings and made daily postings on its facebook and twitter pages. Some AMBUCS members even created videos on youtube.com that promoting the voting campaign, and while other chapters ran newspaper ads in their local papers. AMBUCS eventually finished as the fourth highest vote-getter in the \$50,000 category.

“Yes, it was nerve-racking at times, but shouldered together we were able to persevere and keep our eye on the prize,” said Gary Miles, the 2009-10 National Big Hat Club President. “Words cannot express just how proud I am to be an Ambuc today.”



Thanks to the leadership of National President Cliff Bauerle and the hard work of our members, 2009-2010 saw AMBUCS spread its mission to several new communities. The following new chapters were chartered this year:

The fun and freedom of riding your own bike is something everyone should be able to enjoy. Now, thanks to the AmTryke® therapeutic tricycle, even individuals who are unable to operate a traditional bike can finally realize this wonderful experience.

Established in 1994, AmTryke®, LLC is a company owned and operated by National AMBUCS™, Inc. AMBUCS is a national non-profit service organization dedicated to creating mobility and independence for people with disabilities.

These unique tricycles, which can be hand and/or foot operated, are designed to accommodate riders of all ages, sizes, and varying degrees of physical limitations.

In 2009-10, over **1,800** AmTrykes were provided for individuals with disabilities. To date, over **15,300** AmTrykes have been distributed around the world. The majority of these trykes are purchased by volunteer members of the AMBUCS organization and donated free of charge to financially-needy individuals



AMBUCS™ Scholars- Scholarships for Therapists

AMBUCS™ Scholars- Scholarships for Therapists is a scholarship program for students studying physical therapy, occupational therapy, speech pathology and hearing audiology. Applications are accepted annually from January to April. The 2009-2010 Scholarship Committee included Chairman Patty Vannoy of Lubbock, TX; Alan Bedell of Bloomington, IL; Sophia Befort of Enid, Ok; and Marilyn Flora of Beford, TX.

The AMBUCS Scholarship Committee awarded 207 scholarships totaling \$139,657 for the 2009-10 school year. The average award was \$674.75.

National Conference Report



AMBUCS members and guests from all over the nation convened in Naples, Florida during the week of July 7-10 to celebrate the 88th AMBUCS National Conference. The fun-filled event was held at the Naples Beach Hotel and Golf Club and featured plenty of fun, excitement and learning opportunities.

Guest Speakers

In addition to fun, fellowship and education, great speakers are a tradition of the AMBUCS National Conference. This year was no different, as several special guests enlightened conference attendees with their unique messages.

If **David Glover** has it his way, church-goers around the nation will soon become better equipped to minister to people in their communities who have disabilities. Glover, the founder of the Georgia-based Zachariah's Way ministry, believes the bible taught about caring for those with special needs, but this is one area in which the modern church has fell short.

He is currently working to change that by speaking in churches, conducting bible-based training seminars and using his own ministry manual: "The Disabilities Ministry For Dummies."

During the conference, Glover served as a keynote speaker during the opening general session on July 8 and also led a series of educational sessions about his P.U.R.E Ministry Project – which he calls his biggest effort ever.

She also is a 2007 graduate of ASHA's Leadership Development Program and has served on various ASHA committees.

As a woman with a physical disability, she described just how much her life had been enhanced when she received a new AmTryke therapeutic tricycle last year. Hagensen, who recently moved to Charlotte, NC with her husband David, has cerebral palsy and was unable to ride a traditional bike. However, she received a 2700 series AmTryke and has since been able to join her husband on bike rides and experience her city in a whole new light. According to her, the trike had been a true blessing, both physically and emotionally.

"Word can't express just how much joy this trike has given me," she said. "I ride it all the time and I have never before been able to experience such freedom."

Therapist of the Year

The winner of the 2010 AMBUCS Therapist of the Year Award was **Aimee Carter** from Elgin, Oklahoma.

Nominated by the Mountain Metro, OK chapter, Aimee has amassed more than 15 years of experience working with geriatric and pediatric neuro-based clients.

During her speech at this year's Living Endowment Program, Carter shared with the audience how much she had been able to improve the lives of children with disabilities by incorporating AmTrykes in her therapy sessions.

Using a video PowerPoint presentation, she offered stunning visual evidence of the physical and social developments several of her young patients had experienced after riding AmTryke therapeutic tricycles. Carter began performing AmTryke assessments for Mountain Metro in 2007 and was soon inspired to become an official chapter member herself. Over the years, she has been vital in helping the chapter locate AmTryke recipients. She has even been known to take trykes directly to families at their home and spend countless hours working with each patient.

She currently operates as a self-employed contract physical therapist, in which she provides treatment and consultations for over 30 schools in 11 counties.

Ambuc of the Year

After nearly two decades of unparalleled service and leadership, **Raymond Griest** of Urbana, Illinois was recognized in July as the 2010 National Ambuc of the Year. The honor, which is bestowed annually on the most outstanding volunteer member in the AMBUCS organization, was announced on Friday, July 9 during the organization's 88th national conference in Naples, Florida.

"I was totally blown away when I heard my name called that night", said Griest, who has been dubbed "The Finisher" by his fellow AMBUCS members for his ability to complete important projects. "Words can't express how proud I am to receive such a great honor."

Griest, who joined the Greater Champaign County (GCC) chapter of AMBUCS in 1988, was recognized for his significant contributions to his chapter and his commitment to carrying out the AMBUCS mission. For the past 18 years Griest has served as chairman of his chapter's major fund raising event which earns over \$17,000 in annual revenue. In leading this project, he personally sold over 120 tickets at \$135 each, lined up the major event sponsor, gathered over \$5,000 in door prizes and oversaw all publicity efforts. He also served as chairman of the GCC ramp building committee, in which he has designed and coordinated the construction of more than 250 wheelchair ramps in Champaign County, IL.

Griest also is a Past Chapter President and Past Big Hat President. He is a life member and has been a 100 percent Living Endowment contributor every year since joining.

All throughout the morning, laughter and words of encouragement filled the room as riders were able to experience the joy and freedom of operating a trike for the very first time. Parents and family members were filled with excitement as they witnessed their loved ones having plenty of fun while also gaining mobility and independence.

To make such an event possible, AMBUCS chapters from all over the nation donated hundreds of dollars to sponsor each rider’s individual trike. Many AMBUCS members also volunteered their time and energy to man different work stations inside the ballroom, making sure each rider was fitted properly on their new ride.

Leading the way were therapists **Sue Haywood** and **Fred Sammons**, who with the help of the other volunteer “AmTryke mechanics” made all the proper adjustments and equipment modifications. AMBUCS partnered with local physical therapist Pat Maguire and the Collier County School District to identify the trike recipients.

In addition, the Rodeo was chronicled that morning by a news team from WINK, the local CBS television affiliate. Their heartwarming feature story would air later that same day on the WINK evening news. Also in attendance for this event was **Hannah Simone**, the new Pepsi Refresh Health Ambassador. She was a specially invited guest at this year’s national conference and spent the morning visiting with trike recipients, parents and AMBUCS members to meet and take photos once all the children were announced.

Young, who also once again served co-chair for the Trek, said she continues to be impressed by how hard her fellow AMBUCS members work to make this event a success each year.



AMBUCS™ Scholars 2009 Cumulative Report


2009-10 Recap

AMBUCS™ awarded **207** scholarships totaling **\$139,675** for the 2009-10 school year. The average award was **\$674.75**




Applicants
