

The National AMBUCS Calendar Raffle Rules

1. The purchase of a Calendar Raffle certificate is \$ 25.00. Check or money orders should be made payable to "National AMBUCS, Inc." or one of the subsidiary chapters of National AMBUCS, Inc. Chapters of National AMBUCS, Inc. are permitted to sell Calendar raffle tickets where their respective state law permits. Payments are not tax-deductible contributions. Payments may be made by VISA Bank Cards, Master Cards, or American Express at 1 (800) 838-1845 or on National AMBUCS, Inc. web secure web site <http://www.ambucs.org>. Check or money order may be attached to the completed certificate registration form and mailed to National AMBUCS, Inc., PO Box 5127, High Point, North Carolina, 27262. Upon receipt of completed certificate and payment, ticket/s will be mailed within 10 working days. If an entrant's check, VISA Bank Card or Master Card is dishonored by the bank, the entry certificate will be declared invalid unless full payment is made prior to the drawing. Any dishonored check will be considered an invalid entry and participant will be notified by mail.
2. Completed Calendar Raffle certificate registration forms may be delivered to and must be in the possession of National AMBUCS, Inc. by 5:00 PM EST on February 28, 2005, to be eligible for all Calendar Raffle prizes. Late certificate registration forms will be accepted but will only be eligible for the remaining prizes still available at the time the registration certificate is received. The 2005 Calendar Raffle sales will run from September 25, 2004 to February 28, 2005.
3. Purchasers of Calendar Raffle certificates must be 18 years of age or older.
4. The Grand Prize shall be \$4,800 in cash (four thousand eight hundred dollars). There will also be fifty-two cash prizes of one hundred dollars each. One vacation prize is offered: (1) The winner may choose one week at a timeshare coordinated through the donor and their timeshare vendor. Travel, meals and all other expenses not specifically stated are the sole responsibility of the winner. If prize is condominium lodging, winner must agree to all of the terms and conditions of condominium owner/agent/association.
5. The vacation prize is accompanied by up to \$600 travel allowance which must be used for air transportation from airport nearest winner's residence and will only be awarded if air travel is ticketed through AMBUCS official travel agent.
6. Names of the winners will be available to the media and all raffle participants, and will be displayed on National AMBUCS, Inc web site <http://www.ambucs.org>.
7. There are 6,000 Calendars available to sell. If all 6,000 Calendar Raffles are sold, each certificate has an approximately 1 in 6,000 chance of winning a prize.
8. Winners will be determined by random drawings, the drawing dates will be on the first Monday (business day) of each month beginning March 7, 2005 at approximately NOON EST, at AMBUCS Resource Center or AMBUCS auditor's office. Beginning on March 7th, 2005 and on each succeeding first Monday (if not a business day, then the day following) of each month thereafter, the weekly

prize drawings of \$100 each will be drawn for each month. On March 7th, the weekly winners for January, February, and March 2005 will be drawn. All winners will be notified by mail and/or telephone. The vacation prize will be drawn on April 4th, 2005 as printed on the calendar. The Grand Prize of \$4,800 will be drawn on December 5th, 2005. A list of winners and the complete rules will be posted on National AMBUCS, Inc. web site at www.ambucs.org.

9. Winners may be required to sign and return an affidavit of eligibility, liability release, and when lawful a publicity release within 14 days of notification. Failure to sign and return any documents timely, or if prize notice or prize is returned as non-deliverable, may result in prize forfeiture and selection of another winner. Prizes may not be assigned or transferred, and there will be no substitution of prizes (or cash equivalents), except at the sole discretion of Sponsor for a prize of equal or greater value, due to prize availability. By participating and accepting the prize, winners release Sponsor, its parents, affiliates, subsidiaries, advertising and promotional agencies and their respective directors, officers, agents, employees and representatives from any and all liability and agrees to hold them harmless from any liability for any damages, injury or loss, including death, due in whole or in part, directly or indirectly, to acceptance, possession, use or misuse of a prize, participation in a prize-related activity, or participation in the promotion. By accepting prize, each winner agrees to the use of his/her name, address, photograph, videotape, voice, signature and any likeness for advertising or publicity purpose and to the use of statements made by or attributed to the winner, provided same are true, relating to Sponsor, Sponsor's services or this Calendar Raffle and any and all rights to said use without further compensation, except where prohibited by law. Void where prohibited by law. Any taxes on prizes are the sole responsibility of the winners.

10. More than one name may be stated on the certificate registration form; however, the first listed name shall be deemed the "entrant". The Social Security number provided must be that of the entrant. Payment or delivery of any prize shall be made solely to the entrant. It is the sole responsibility of the entrant in the multiple party entry to allocate any such prize among the participants in the multiple party entry.

11. The decision of National AMBUCS, Inc. shall be final on all matters concerning the Calendar Raffle.
